Please initial to show you understand and agree to the following terms below:

_____ Due to buyer demand, the breeder maintains a paid waitlist to ensure serious intent to purchase a Bengal from Bougie Bengals. The Buyer has paid a \$200 non-refundable waitlist payment to be placed to join the waitlist for an upcoming kitten and/or retired adult. This payment will be applied toward the total purchase price of the cat. This waitlist payment is non-refundable if the Buyer decides, for any reason, not to purchase a Bengal from the Breeder.

_____ The Buyer agrees they have read through and understand the Breeder's website including the Kitten Contract, Retired Adult Contract, About The Breed, Natural Rearing, Cat Nutrition, About Our Program, Upcoming Pairings, Cat Behavior and Cat Enrichment pages.

_____The Buyer understands that Bougie Bengals prices are currently \$3,500 for kittens and \$1,500 for retired adults.

_____The Buyer understands that the purchase price of their kitten does not include transportation or delivery. If Buyer elects to use Bougie Bengals' transportation services, the following fees apply: airport delivery to Nashville International Airport (5 hour round trip) is \$200; ground delivery up to 5 hour round trip is \$200; ground delivery over 5 hour round trip is \$100 daily car rental fee +\$1.50 per round-trip mile; and if transportation requires an overnight stay due to distance, scheduling, or travel logistics, hotel accommodations will be charged in addition to transport fee. USDA-certified flight nanny services are arranged and paid for separately by the Buyer. Transportation and delivery fees are subject to change. The rates in effect at the time transportation is scheduled will apply. All transportation fees are due prior to travel and are non-refundable once transportation has been scheduled.

_____The Buyer agrees and understands that it is their responsibility to research the Bengal breed to determine whether it is a good fit for their home and lifestyle.

_____The Buyer understands they will be contacted by the Breeder via text and/or email and agrees to provide contact information that is checked regularly. If the Buyer does not respond within the allotted timeframe, the Breeder will move to the next person on the waitlist.

_____The Buyer agrees to select an available kitten or retired adult within three (3) years from the date the waitlist payment was received. Buyers may pass on available cats and will retain their place on the waitlist. If the Buyer does not select a cat within the three-year timeframe, they will be removed from the waitlist and the waitlist payment will be forfeited.

_____The Buyer understands that the waitlist is not based on color, pattern, or gender preference. When the Buyer's turn on the waitlist is reached, the Breeder will share the kittens or cats that are currently available. The Buyer will have 48 hours to either reserve one of the available cats or pass and remain on the waitlist for future availability. Failure to respond within the 48-hour period will result in the Buyer losing their turn, and the Breeder will move to the next person on the waitlist.

_____The Buyer understands that while waitlist order is considered, the Breeder reserves the sole discretion to determine the availability and final placement of each kitten or retired adult. Waitlist position does not guarantee the availability of any specific kitten or retired adult. All placement decisions made by the Breeder are final.

_____When the Buyer's turn on the waitlist is reached, the Breeder will offer the available kitten(s) or retired adult(s). The Buyer will have 48 hours to notify the Breeder of their selection, complete and sign the applicable Kitten Contract or Retired Adult Contract, and submit the reservation payment equal to 50% of the purchase price. If all 3 requirements are not completed within the 48 hour period, unless otherwise agreed to by the Breeder in writing, the Buyer will forfeit their selection, and the Breeder may offer the kitten or retired adult to the next qualified buyer.

_____The Buyer understands that a 50% reservation payment is due upon signing the applicable contract to reserve the selected cat. For kittens, the remaining 50% balance is due when the kitten reaches 12 weeks of age. For retired adults, the remaining 50% balance is due two weeks before the scheduled go home date. If the selected kitten or retired adult is already available or is scheduled to go home within two weeks of the reservation date, the full purchase price is due upon signing the applicable contract.

_____The Buyer understands that until kittens are born, the Breeder cannot guarantee the number of kittens, their sex, color, or availability. Kittens will be evaluated between 4–8 weeks of age before being made available to buyers on the waitlist.

_____The Buyer understands that the Breeder is committed to the preservation, development, and improvement of the Bengal breed. The Breeder therefore reserves the right to retain any kitten or cat for their program or place with an approved breeding program when the Breeder believes the placement may contribute to the advancement of the breed.

_____The Breeder reserves the right to cancel any sale at any time and refund any payments made.
